Awards are made to State Educational Agencies (SEAs). Local education agencies (LEAs) and nonprofit organization may apply to states for sub-grants.

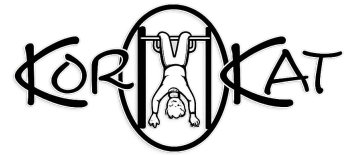
